### **OVERVIEW OF INCOMING SIGNALS**

The following information is based on incoming communication with the National Human Trafficking Hotline from January 1, 2021 – December 31, 2021 about human trafficking cases and issues related to human trafficking in Oklahoma. Communication can take the form of **phone calls, SMS, Webchat¹, online tip reports², or emails.** Communication regarding topics unrelated to human trafficking are not included in this report. In 2021, the National Human Trafficking Hotline received a total of **438** substantive³ phone calls, SMS, Webchats, emails, or online tip reports from Oklahoma.

### SUBSTANTIVE SIGNAL DATA

The following statistics are based solely on substantive signals about human trafficking and issues related to human trafficking made to the National Human Trafficking Hotline between January 1, 2021 and December 31, 2021 from signalers in Oklahoma at the time of their signal. Substantive signals exclude hang-ups, missed calls, wrong numbers, and signals in which the signaler's reason for contacting is unknown.

#### Number of Substantive Signals Received from Oklahoma: 438

This constitutes the 24th highest signal volume of all 50 states and Washington, D.C. in 2021.

### **DATA ABOUT HUMAN TRAFFICKING SITUATIONS**

Each request submitted to the Hotline is evaluated for evidence of potential human trafficking. In Oklahoma, a total of 99 unique situations (incidents) of potential human trafficking were reported to the Hotline.

This category also includes cases in which the person reporting the information references human trafficking but does not provide further detail regarding the presence of labor or commercial sex. These cases are often submitted to the Hotline through anonymous online tip reports.

The National Human Trafficking Hotline cannot verify the accuracy of the information reported. This is not a comprehensive report on the scale or scope of human trafficking within the state. Data is dynamic and subject to change as the hotline continues to respond to victims of trafficking. Therefore, the data reported is likely to have minor fluctuations based on when the data for the report was retrieved. The current report is based on data retrieved on November 15, 2022, 5:00 PM.
