Massachusetts State Report: 1/1/2020 – 12/31/2020

OVERVIEW OF INCOMING SIGNALS

The following information is based on incoming communication with the National Human Trafficking Hotline from January 1, 2020 – December 31, 2020 about human trafficking cases and issues related to human trafficking in Massachusetts. Communication can take the form of phone calls, SMS, Webchat¹, online tip reports², or emails. Communication regarding topics unrelated to human trafficking are not included in this report. In 2020, the National Human Trafficking Hotline received a total of 232 substantive³ phone calls, SMS, Webchats, emails, or online tip reports from Massachusetts.











¹ Webchats are a means of communicating with hotline staff directly on the website using the online chat feature

SUBSTANTIVE SIGNAL DATA

The following statistics are based solely on substantive signals about human trafficking and issues related to human trafficking made to the National Human Trafficking Hotline between January 1, 2020 and December 31, 2020 from signalers in Massachusetts at the time of their call. Substantive signals exclude hang-ups, missed calls, wrong numbers, and signals in which the signaler's reason for calling is unknown.

Number of Substantive Signals Received from Massachusetts: 232

This constitutes the 35th highest signal volume of all 50 states and Washington, D.C. in 2020.

DATA ABOUT HUMAN TRAFFICKING SITUATIONS

Each request submitted to the hotline is evaluated for evidence of potential human trafficking. In Massachusetts, a total of 81 unique situations (incidents) of potential human trafficking were reported to the hotline.

²Requests for general information are situations in which an individual who is aware of a specific situation of potential trafficking may contact the National Human Trafficking Hotline for general information about human trafficking or to learn more about services available to trafficking victims. Requests for T&TA (Training and Technical Assistance) are situations in which service providers or law enforcement working with a victim of trafficking contact the National Hotline for technical assistance.

This category also includes cases in which the person reporting the information references human trafficking but does not provide further detail regarding the presence of labor or commercial sex. These cases are often submitted to the National Hotline through anonymous online tip reports.
